### DRI professional certifications

All DRI training courses, except the IT DR Planning course, are concluded by a certification examination. Among the certifications that can be applied for, those at the first level, ABCP or ACRP, only require passing the exam and, at DRI Italy only, are included in the cost of the course. For those wishing to acquire the higher level certifications, CBCP, CBCV or CCRP, these require proof of at least two years' professional experience in this field and payment of the additional fee indicated below
