Payment Methods

Payment must be made and received <u>prior to the course start date</u>. All DRI Italy courses are confirmed subject to a minimum number of participants. In case of cancellation of your chosen date, DRI Italy will contact you to arrange a new date or refund the amount paid.

DRI Professional Examination and Certification

All DRI training courses, except the IT DR Planning course, are concluded by a certification examination. The examination is normally scheduled by the teacher at the end of the week in which the course is held; however, the participant is free to access the online platform and take the examination independently, at a time of his/her choice. Among the certifications that can be applied for, the first-level ABCP and ACRP certifications only require passing the examination. For those wishing to acquire the higher certifications CBCP, CBCV and CCRP, these require proof of at least two years' professional experience in the field. The first issue of all certifications requires payment of a one-off fee (between 200 and 400 USD) and directly on the DRI main website www.drii.org and only after successfully passing the examination.



GENERAL TERMS and CONDITIONS

- **1. Subject matter:** The subject matter of these general terms and conditions is the provision of a DRI training course by PhoenITx S.r.l., an affiliate of DRI International for Italy and France.
- **2.** Enrolment: enrolments for courses must be made by sending this enrolment form, duly completed in all its parts and signed by e-mail. This form has the value of a Purchase Order.
- 3. Cancellation and cancellation: course enrolment may be cancelled by the participant by e-mail, which must be received at least 20 days before the start of the course. After this date it is only possible to request up to 7 days before the start of the course a transfer of enrolment to a subsequent course of the same type within 12 months. In the event of failure to cancel within the deadline or if the participant discontinues attendance during the course, the entire fee will be withheld. The substitution of the participant is permissible subject to written notification no later than the working day before the start of the course.
- **4. Postponement and cancellation of courses:** DRI International may postpone or cancel the course at any time by giving written notice and refunding the amounts received by way of enrolment, except in the case of any agreement to change the date or venue. Any refund other than the course fee alone is excluded.
- 5. Payment: enrolment is confirmed on receipt of payment by the course start date, unless otherwise agreed. All DRI Italy courses are confirmed subject to a minimum number of participants. In case of cancellation of your chosen date, DRI Italy will contact you to arrange a new date or refund any amount paid.
