The purpose is to help them best define the characteristics of the Disaster Recovery Plan to be dedicated to the **recovery of IT services**. Although the course does not have a technical focus, it includes an overview of available technology solutions.

- CBCP, Certified Business Continuity Professional** - for those with more than two years of experience;
- CBCV, Certified Business Continuity Vendor** - for consultants and providers of DRP and BCM solutions;
- MBCP, Master Business Continuity Professional** - for those with more than five years of experience, requires a second exam;
- ACRP, Associate Cyber Resilience Professional** - for those with less than two years of experience;
- CCRP, Certified Cyber Resilience Professional** - for those with at least two years of experience.

Certification Examination

The **certification exam** takes place upon completion of all courses on BCM and Cyber Resilience. Passing it is essential to apply for DRI certification. The exam lasts 2,5 hours, **is online** and consists of 100 **multiple-choice** questions in **Italian or English**.

Once the exam is passed, **the DRI certification** most appropriate to the applicant's needs and experience **can be applied for**. The student still receives a **certificate of attendance**.

Modalities of participation

Cyber Resilience Review - CRP501 - Duration: 2.5 days. The course provides all the information needed to take the certification exam that completes the course.

IT Disaster Recovery Planning - Duration: 2 days, no certification exam. The course guides the application of Business Continuity Management concepts in defining an IT services Disaster Recovery program.
